



PROCEDURE - TRANS TASMAN VISAS

Application for Trans Tasman Visa

Australian Competitors wishing to compete in New Zealand

Under the Tasman Agreement between the Australian Karting Association and KartSport New Zealand a Competition Visa is required. The Australian Karting Association issues this Competition Visa. If you wish to race in New Zealand, your Australian Karting Association License will be recognized but you will require a Competition Visa. Please complete the appropriate form, which is available for download from www.austkarting.com.au and forward to the AKA National Office @ admin@austkarting.com.au with the appropriate application fee. Please allow 14 to 21 days for the processing and return of your VISA prior to your departure to New Zealand.

Application for International Licence and Visa to Compete

New Zealand Competitors Competing in Australia

Under the Tasman Agreement between KartSport New Zealand and the Australian Karting Association a Competition Visa is required. This Competition Visa is issued by the KartSport New Zealand National Steward. If you wish to race in Australia, your KartSport New Zealand Competition License will be recognized but you will require a Competition Visa and a Medical Card. Examples of the Kart Sport New Zealand Trans Tasman Visa and the Kart Sport New Zealand Medical Examination Card are attached.

FOR MEDICAL OFFICERS

Before each event the responsible Medical Officer will take possession of the present form and will return it to the person concerned only after the competition.

In the event of an accident, the Medical Officer must, in the space reserved for the purpose, enter the medical observations regarding any injuries suffered and return the form to the ASN as soon as possible. The pre competition clearance can be substituted by the examination by the medical officer on the form.

FOR DRIVERS

Drivers are under strict obligation to present this form for checking, and also to give it to the responsible Medical Officer before each event. Failure to do so will entail non-eligibility to compete.

I undertake that I will not use any substances intended to artificially and temporarily increase physical capabilities and liable to be detrimental to my health, particularly those substances appearing on the International Olympic Committee list.
